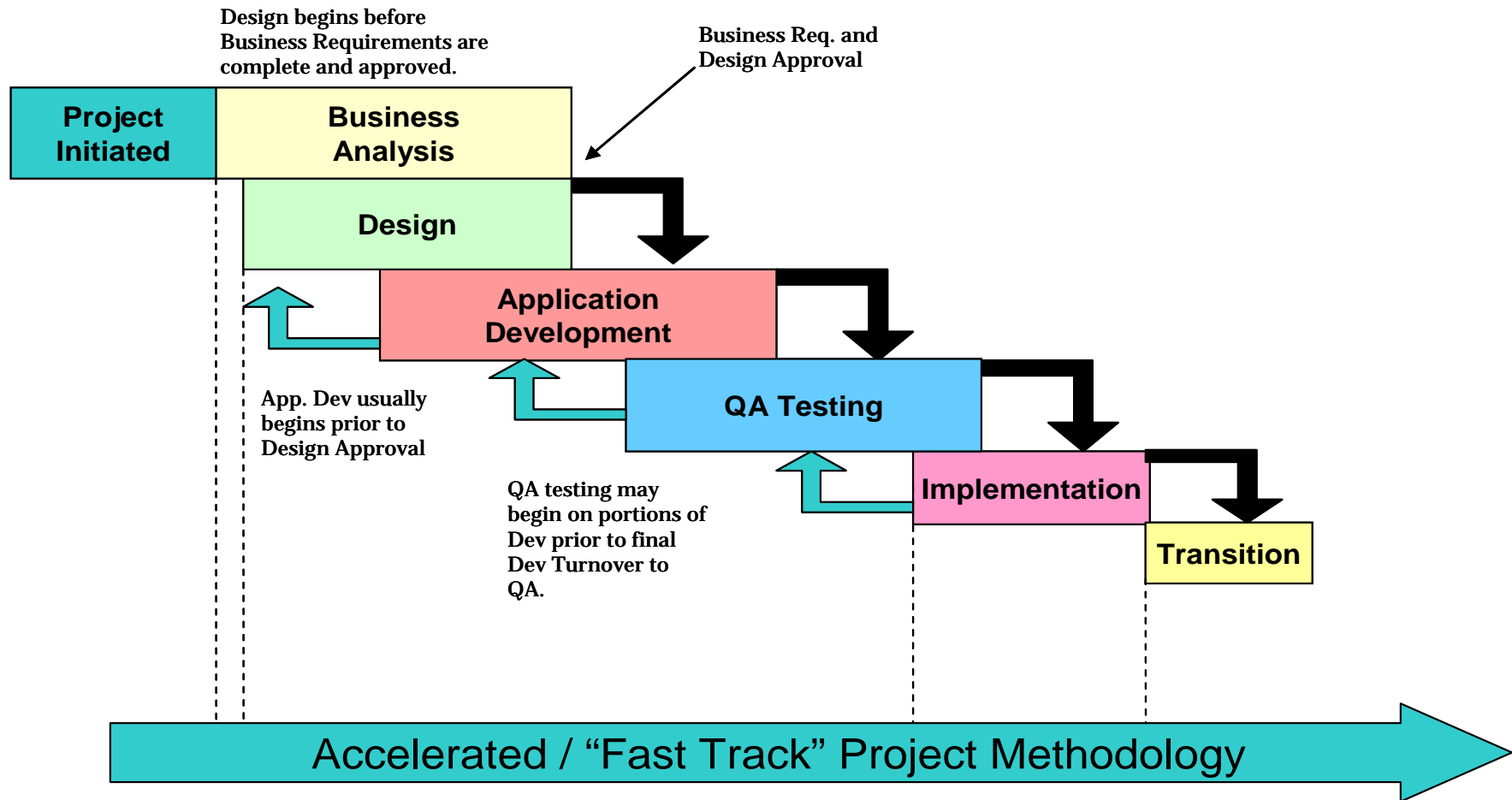

2. Training & Implementation

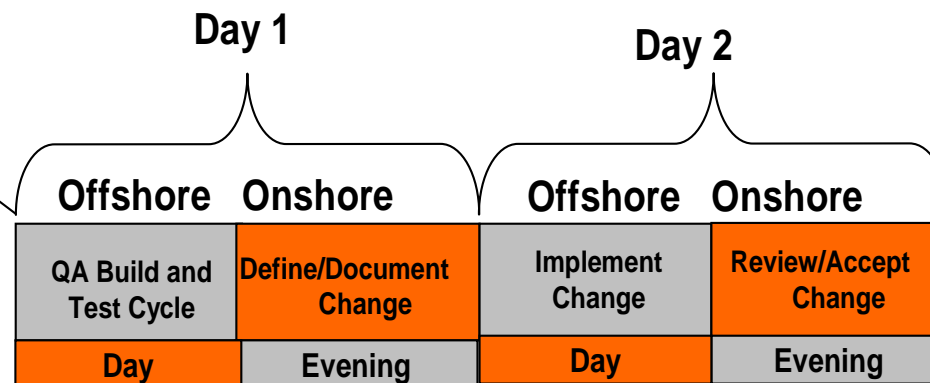
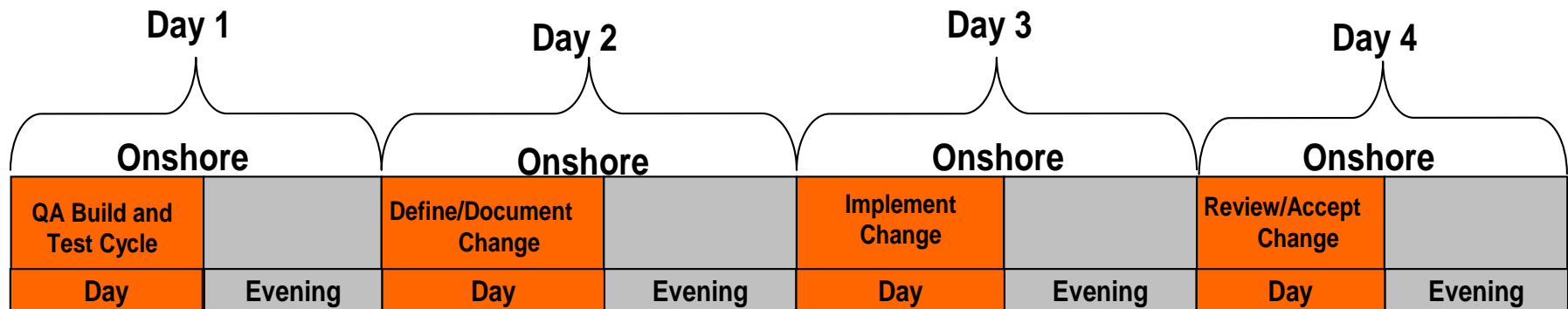

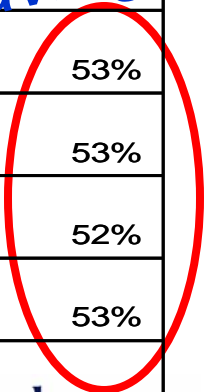
